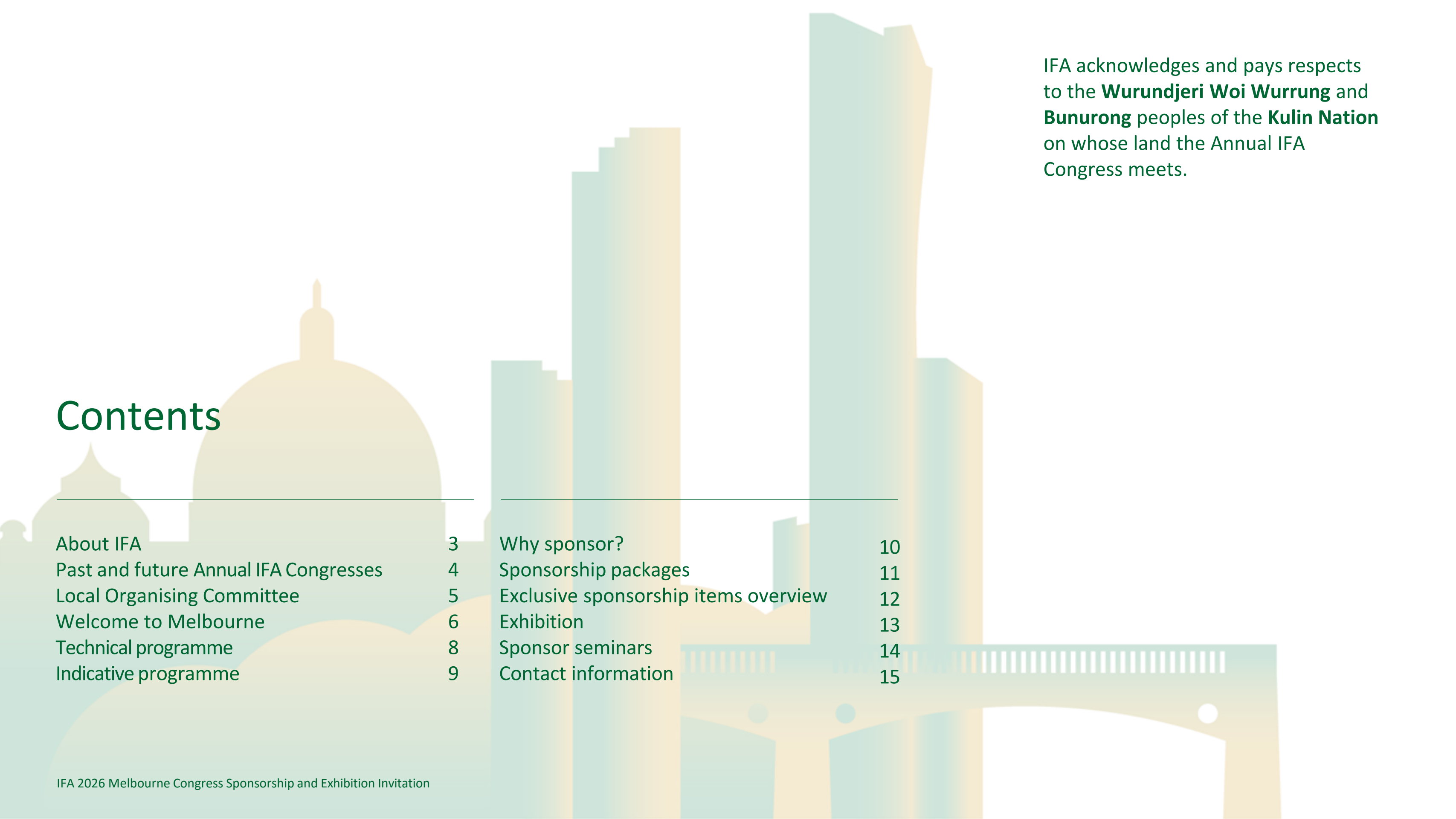

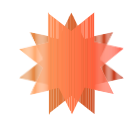

*** In respect of the other sponsorship categories, the assignment of the items will be made on a first-come, first-served basis.

Exhibition



Standard rate: 12,000 EUR/21,500 AUD

Non-profit rate: 8,000 EUR/14,500 AUD

Exhibit space (9 sqm) can be offered at the aforementioned fees VAT/GST excluded.

Each stand of 9 sqm includes:

- Shell-scheme with carpet on the floor and general lighting
- Basic power supply
- 2 exhibitor passes

- An adjusted price will apply for larger exhibit spaces. For instance, 6x3 exhibit space is 20,000 EUR/36,000 AUD, VAT/GST excluded.
- The exhibit space allocation choice will be according to the sponsorship level first, and then on the basis of the date of contract signing. Final decisions regarding the allocation of space are at the sole discretion of Global IFA.
- Additional exhibitor passes can be purchased separately through the registration page.
- Exhibitor passes give access to the exhibition hall and the YIN party.
- All exhibitor passes are personal and for the exclusive use of the person in whose name they have been issued. They cannot be shared for different days of the Congress.
- Exhibit contractor set up staff who are not designated with a full exhibitor pass must leave the exhibition hall by 2pm on Sunday before the start of the Congress.

Sponsor seminars

- Sponsors and exhibitors as well as non-profit and academic entities have the right to conduct sponsor seminars before (breakfast seminar) or after (afternoon seminar) the official seminars for the price of **8,000 EUR/14,500 AUD**, VAT/GST excluding, if the available seminar rooms are not purchased by Green sponsors.
- Allocation of seminar rooms is at the sole discretion of Global IFA.
- All additional costs in relation to the sponsor seminar shall be borne by the sponsor.
- The proposed theme, content and speakers of the sponsor seminar shall be notified by the interested sponsor at least 3 months in advance to Global IFA with a request for approval.
- All sponsor staff attending a sponsor seminar must be registered as full Congress delegates; sponsor staff supporting the seminar must be registered with an exhibitor pass (either included in the package or purchased separately).
- All speakers of the sponsor seminar must be registered as full Congress delegates.
